

## SECRETARY'S REPORT TO THE 2023 AGM

Being Secretary this past year has been an honour although I sometimes feel that I have not been as fully active and competent as I could. Life and work is becoming increasingly busy for all of us and this also means we, as IA practitioners, can become increasingly disconnected when we need it the most. Being part of an NZAIA community is important to share ideas, practice and a sense of collective effort, despite our work being very much individualised and project-based.
